ORDER

Whereas, the Dept. of Higher Education, Govt. of Jammu & Kashmir accorded sanction in favour of Model Institute of Engineering & Technology, Kot Bhalwal, Jammu vide No. HE/Engg./27/96 dated 18.09.1998 for setting up of a College of Engineering and Technology & consequent upon approval accorded by the All India Council for Technical Education, New Delhi, vide No. F:765-64-205(E)/ET/96 dated 19.08.1999.

Whereas, in pursuance of the above said approval/s /NOC the matter with regard to temporary affiliation of the MIET was considered by the University and in anticipation of the approval of the Board of Inspection and the Syndicate, the temporary affiliation was granted to the aforesaid College vide letter No. CDC/99/370-7 dated 04.02.1999 with three branches of engineering (Computer Science & Engineering, Electronics and Communication Engineering, Electrical Engineering); and was further extended by the University on year to year basis;

Whereas, the Chairman, MIET applied for grant of permanent affiliation vide letter No. MIER/ 2012/468-70 dated 18.08.2012;

Whereas, the University constituted an Inspection Committee comprising inter alia the experts in the field, which conducted the Inspection of the College on 30.11.2016, and while recording its observations, recommended as under:

"Keeping in view the above achievements, adequate physical infrastructure including Labs and Library, the Committee recommends grant of permanent affiliation in favour of MIET, Kot Bhalwal, Jammu."

Whereas, the aforesaid report of the Inspection Committee was placed before the Board of Inspection for consideration in its meeting held on 07.07.2017, wherein it was Resolved that-

"Inspection report for grant of permanent affiliation in favour of Model Institute of Engineering & Technology, Kot Bhalwal, Jammu, be accepted subject to verification of record that it is being run by a non-profit earning Trust/Society/Company and that it is not imparting education for private gain or profit as provided under statute 4(4.3) of the statutes governing affiliation of Colleges and other Institutions".

Accordingly, the Institution was asked to submit an affidavit from Ist Class Magistrate and which was submitted by the college vide letter No. MIER/2017/2489 dated 15.11.2017. Since, the matter for grant of permanent affiliation was placed in the 113th University Syndicate and was further endorsed to 84th University Council held on 10.04.2018.Wherein,it was Resolved that-

"The case of Model Institute of Engineering & Technology, Kot Bhalwal, Jammu for grant of permanent affiliation, be approved."

Now, therefore, in pursuance of the resolution of the University Council, the Model Institute of Engineering & Technology, Chak Bhalwal, Jammu is granted permanent affiliation w. e. f. the academic session 2018-19.
